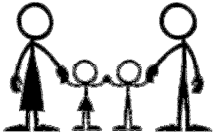

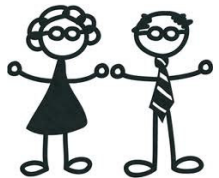
2016 Memberships
